The Tennessee Division, United Daughters of the Confederacy held their 115th convention at the Pickwick Landing State Park in Pickwick Dam, Tennessee, October 6-8, 2011, and it was an exciting Sesquicentennial journey to the Shiloh Battlefield area. I'm sending a report of the many once-in-a-lifetime occasions we shared at this convention.

Thursday was a tour of historic Savannah, Tennessee, including several historic sites, Taylor House, Ross House, White Elephant, Irwin House and First Presbyterian Church, as well as the River City Museum, where a reception was held for the members. The division officers were guests at Cherry Mansion for dinner. Watching the sunset over the Tennessee River on the back porch of the home you could not help but think of

how Union General U.S. Grant must have felt as he watched his men and supplies flowing down the River to Pittsburgh Landing at the battlefield. Two Union Generals died in Cherry Mansion, headquarters of Gen. Grant at the battle of Shiloh. The mansion is now a private home, where we were privileged to visit by invitation of the owners.

Friday morning we boarded two private bus coaches with Park Rangers of the National Park Service for tours of the Shiloh Battlefield. At noon we had lunch at Hagy's Catfish Hotel and were stuffed when we left there. The Memorial Service, where we remember all deceased members from the past year, was held in the Shiloh Methodist Church, located at the site of the original church, which gave the name to the battle of Shiloh. The service was made even more memorable when world-famous author of "We Are Standing On Holy Ground," Geron Davis, a native of Savannah, Tennessee, played and sang this and other songs he wrote and composed as part of the service.

We again boarded our busses and went to the UDC Confederate Monument, the largest Confederate monument on Shiloh Battlefield. The centerpiece of the TN Division UDC 150th logo and pin, is "Victory Defeated By Death & Night," the main feature of this UDC Confederate monument in Shiloh. We went to the Tennessee Confederate Monument, and one of the five marked Confederate Mass Burial pits. The TN UDC placed wreaths of remembrance at all of these locations in the Park.

When the officers were having dinner at Cherry Mansion, I could not help but think of the hundreds of wives, sisters, mothers, fathers, and other family members who had gone there to ask General Grant for permission to locate and bury their men. All were denied. Today there is a beautiful

Union soldier cemetery at Shiloh, with every soldier who could be identified from papers on their bodies, marked with their name. The Confederate soldiers were stripped of anything that could identify them and the identification was burned. Then anything they had on that could be used by the Union army was stripped from their dead bodies and they were thrown into mass burial pits and covered over. If your ancestor was a Confederate who died at the Battle of Shiloh, they will never have an identified grave.

Friday evening was the formal opening ceremony, highlighted by men in Confederate uniform from the Battle of Shiloh Camp 1454, who held crossed swords as the UDC Vice President General, the UDC Third Vice President General, the Commander-in-Chief of the Sons of Confederate Veterans, and the Tennessee Division UDC President passed under them in procession. The speakers for the evening were Mrs. Ruth Allbritton, UDC Vice President General, of Blue Mountain, Mississippi, and Mr. R. Michael Givens, Commander-in-Chief of the Sons of Confederate Veterans, who had driven fifteen hours to our convention from a speaking engagement in Pennsylvania.

CIC Givens presented TN Division President, Barbara Parsons, with the Commander-in-Chief Ladies Appreciation Medal for aiding the SCV in carrying out its mission on the national level. Mrs. Matilda Speck of Livingston, Mrs. Brenda McDonald of Kingston, and Mrs. Dore Dorris of Southaven, MS, were presented the Winnie Davis Medal for outstanding service to UDC. One Vietnam Cross of Military Service and two National Defense Medals were presented for service during Korea and the Persian Gulf conflicts. A service remembering all military persons from Tennessee who died in combat in the past year was conducted by TN Division Chaplain, Jo Hill.

The Saturday meetings were business meetings including bylaw changes, chapter presidents and committee chairmen reports, and presentation of awards for the past year's work. Thanks to the hard work of convention co-chairs, Mrs. Bettye Stanley and Mrs. Patsy Weatherington, and the assistance of the Shiloh #371, Capt. Nathaniel A. Wesson #2396, Joe Wheeler

#1077, and Elizabeth Bate Williams #1911 chapters, it was a most successful and memorable 115th annual convention, which will stay in our hearts and memories forever. THANK YOU all for your hard work on behalf of the members of the Tennessee Division UDC.
